BOILER WARRANTY
AC AND A3C SERIES BOILERS

This limited warranty extends to any owner of an Aldrich commercial boiler at the original installation address only.

The Aldrich Company warrants the boiler (less burner and controls) to be free from defects in material and workmanship under normal use and service for a period of ten (10) years from the date of original installation or for a period of ten (10) years and six (6) months from date of manufacture, whichever may be earlier.

For failure within five (5) years from date of original installation or five (5) years and six (6) months from date of manufacture, whichever may be earlier, a replacement boiler or defective part, less burner and controls will be furnished free of charge f.o.b. factory with the owner assuming any freight, labor, and installation charges. If failure occurs in the sixth to tenth year, a replacement boiler or defective part less burner and controls will be furnished at a percentage of the prevailing suggested list price as follows: during the sixth year of service 50%, seventh year 60%, eighth year 70%, ninth year 80%, and tenth year 90%. Owner assumes any freight, labor and installation charges.

Burner and controls are warranted for one (1) year.

Upon request, all defective parts will be returned by the owner to the factory, freight prepaid, for inspection, and all replacement parts will be furnished f.o.b. factory. Aldrich Company will not be responsible for charges, labor costs, or contingent damages.

Any replacement boiler or defective part furnished under this limited warranty will be covered only for the unused portion of the original period, dating from the date of original installation.

This limited warranty shall not be valid unless the boiler has been installed, adjusted, and maintained in accordance with state and local codes and accompanying instructions furnished with the boiler.

It is expressly understood that the limited warranty is not applicable to the following conditions:

1. Discolorations or odors due to chemical properties of water.
2. Leaks or failure resulting from water pressure in excess of approved working pressure.
3. Collapse of boiler pressure vessel resulting from partial vacuum.
4. Operation in excess of the Aldrich specified firing rate.
5. Leaks from loose or defective fittings.
6. Leaks resulting from accumulations of lime and sediment.
7. Leaks from connection to an additional external source of heat.
8. Improper maintenance, neglect, misuse, abuse, alteration or accident.
9. Use of inappropriate water conditioning or treatment systems.
10. Waterside corrosion or scaling is not covered.

Except for the express warranties stated above and to the maximum extent permitted by law, the product is provided "AS IS" and Aldrich Company disclaims all other warranties, including without limitation any implied warranty of merchantability, fitness for a particular purpose, or non infringement of third party rights. Aldrich Company will not be liable to any customer or third party for any indirect, special, incidental, consequential, exemplary or punitive damages.
